Our Company

Northland Power is a power producer dedicated to developing, building, owning and operating clean and green global power infrastructure assets in Asia, Europe, Latin America and North America. Our facilities produce electricity from clean-burning natural gas and renewable resources such as wind, and solar. We have a long track record of over 35 years in business. Headquartered in Toronto, Canada, with active development in 12 countries, we are publicly traded on the Toronto Stock Exchange (TSX: NPI).

Northland's Values

Northland's business partners, suppliers and vendors play an integral role in helping us to accomplish our purpose and live our values. This Supplier and Partner Code of Conduct (the "Code") provides the foundation on which we build these relationships and ensure they continue to thrive with mutual understanding and responsibility for our communal impact on our people, our communities, our planet and our businesses.

We expect our partners, suppliers and vendors to adhere to this Code, to comply with applicable laws, to uphold our values in respecting the highest standards of health and safety, environmental management, human rights and labour rights, and to act with transparency, integrity and respect.

Northland maintains the right to monitor compliance to the Code and where required to conduct due diligence over adherence to this Code and any other applicable Northland policies within the counterparty's control environment. Northland may request information and/or documents from its counterparties to confirm their compliance with the principles of this Code and any other applicable Northland policies.

This policy is reviewed annually by the Board of Directors of Northland Power.



People

Human and labour rights

Northland has implemented a Human Rights Policy and adheres to the [United Nation's Guiding Principles on Business and Human Rights](#) and respects the rights and dignity of all employees and stakeholders. Everyone is entitled to fair treatment, courtesy and respect.

We expect our suppliers and partners to:

- Respect internationally recognized human rights, including the United Nations Guiding Principles On Business and Human Rights.
- Prohibit, directly and indirectly, the use of slavery, forced labour, and child labour in accordance with local regulations and international standards.
- Not tolerate discrimination, abuse or harassment towards any person at any working location.
- Provide employees with fair wages at/or above the statutory minimum wage and adhere to acceptable working hours.
- Acknowledge employees' right to participate in trade unions.

Health and Safety

Northland is deeply committed to upholding the highest standards of safety and prioritizing the health and well-being of our people, contractors and other stakeholders.

We expect our suppliers and partners to ensure that their employees:

- Have the right to a safe workplace.
- Have the right to refuse work and remove themselves from situations that could cause injury or ill health.
- Receive adequate health and safety training.

Diversity, Inclusion and Belonging

Northland is committed to fostering an environment of belonging and empowerment so that all employees, regardless of, among other things, background, age, gender identity or expression, race, ethnicity, religion, sexual orientation, disability, or experiences, feel respected and comfortable fully being themselves at work.

Northland expects its suppliers and partners to be equally committed to promoting diversity and equal opportunities for their employees.

Planet

Northland is committed to decarbonization and managing our planet's shared resources. We expect our suppliers and partners to demonstrate a proactive approach to contribute to our environmental commitments, by actions such as (but not limited to):

- **Promoting sustainable consumption of energy and natural resources, including reducing emissions and generated waste. This includes but is not limited to operations with consideration for product lifecycle and value chain.**
- **Minimizing any potential environmental impacts and protecting and conserving biodiversity.**
- **Minimizing water withdrawal in their operations, reducing/mitigating impacts to bodies of water in and around their sites and recycling as much of the water taken/withdrawn as possible.**
- **Minimizing the use of hazardous materials and ensuring appropriate management process.**
- **Ensuring compliance with all permitting obligations, applicable laws and best environmental management practices.**

Community

Northland is a committed community partner and believes in early and regular engagement and consultation with its communities at every stage of the project lifecycle. Creating positive social impact through our projects is central to this process and is achieved by developing opportunities to support and enhance local communities where we operate.

We expect our suppliers and partners to:

- Demonstrate preferential local hiring and subcontracting practices, and material suppliers, governed by cost competitiveness and adherence to Northland standards.
- Engage with local communities and other relevant stakeholders.
- Respect the communities where they operate.
- Invest directly and/or indirectly in communities where they operate.



Business

The core of Northland's business strategy is to create sustainable, long-term value and prosperity for all stakeholders across Northland's global operations.

Honesty, transparency and integrity are integral to Northland's governance mandate. As such, we conduct business in accordance with the highest ethical standards in all aspects of our activities. We expect the same from our business partners.

Business Integrity and Anti-Corruption

Northland does not tolerate any form of bribery or corruption practices, whether direct or indirect, as part of our business. We expect the same standards from our business partners and to have appropriate procedures in place to prevent and report conduct that contravenes applicable anti-corruption laws, rules and regulations.

We require our suppliers and partners to:

- Comply with all applicable laws, rules, regulations and internal policies and procedures, including this Code and Northland's Anti-Bribery and Anti-Corruption Policy.
- Not offer or make corrupt payments to any person, or solicit such payment from any person, including public officials or private individuals, in order to obtain or retain business or to obtain a business advantage for Northland.
- Report to Northland any actual or suspected improper bribery and corruption conduct that is in violation of this Code and Northland's Anti-Bribery and Anti-Corruption Policy.

Sustainable Supply Chain

Northland expects our suppliers and partners to take reasonable steps to ensure procurement of materials and services from ethical sources. This includes not benefiting, directly or indirectly, from child or forced labour or any other discriminatory work practices.

Supplier and Partner Commitment

We expect our suppliers and partners to comply with all laws, rules and regulations applicable to Northland's business in the countries in which it operates.

We also expect our suppliers and partners to understand and comply with the requirements of this Code. In the event of serious and/or persistent violations of this Code, Northland reserves the right to review the business relationship with the supplier and take appropriate action.

As a condition of doing business with Northland, you are required to comply with this Supplier and Partner Code of Conduct.
